**SCHEDULE**

1. Replace sub-clause 2(50) **DEFINITIONS** which reads: **“ordinary hours of work”** means the hours of work prescribed in clause 5(1), but if by agreement between an employer and employee the latter works a lesser number of ordinary hours, it means such shorter hours, and excludes any hours paid at a premium for work performed on a Sunday or Public holiday or in respect of overtime with the following:

**“ordinary hours of work”** means the hours of work permitted in terms of clause 5 or in terms of any agreement in terms of clause 5(2) or 5(3).
